THE TO LEDO SAILING CLUB

House Rules

- 1. The clubhouse is open (24) hours every day of the year, with bar hours from 5:30 a.m. 1:00 a.m (unless otherwise stated within current State of Ohio liquor license). Financial losses of the club resulting from violation of this rule shall be assumed equally by all members in the clubhouse at the time of the violation.
- 2. Keycards or key fobs, issued to a member, may only be used only by that member or their spouse. Keycards or key fobs may be used by their children for restroom privileges.
- 3. Every member must be prepared to present their membership card upon request when in or around the clubhouse.
- 4. Members of affiliated yacht clubs and their guests may be admitted to the clubhouse upon presentation of the proper identification. Guests of members not affiliated with a recognized yacht club must be accompanied by a member for admission to the clubhouse. All guests from affiliated clubs must sign the visitor's book immediately upon arrival.
- 5. Members shall be responsible for the conduct of their guests and for any debt incurred by them at the club. Members shall be liable for damage to club property by willful or negligent acts of themselves or their guests. Guests shall not be left alone in the clubhouse.
- 6. Only members and paid personnel are allowed behind the bar. No one is allowed behind the bar when a paid bar person is on duty with the exception of the Bar Manager, kitchen employees and/or approved relief of said bar person. Relief to be determined by Bar Manager, or paid bar person. Kitchen volunteers may enter the bar only to access the walk-in cooler area.
- 7. Members and guests will be denied entry into the clubhouse if they are not properly attired. Shirts and shoes are required at all times inside the clubhouse.
- 8. Storage of personal belongings of individual members on club property is forbidden. The club shall not be responsible for the loss of property or any other loss sustained by an individual or their guests.
- 9. The bringing of any outside alcoholic beverage(s) on the decks, porch or into the clubhouse is prohibited.
- 10. There shall be no parking in the delivery/loading zone at any time other than to make a delivery. At no time shall delivery parking exceed thirty (30) minutes.
- 11. Pets are not permitted in the clubhouse at any time, and are to be on a leash at all times while on club property. Service animals, with all current documentation readily available, shall be the only

- exception. Members are responsible for cleaning up after their pets/service animals on club property.
- 12. Garbage shall not be thrown into the harbor or left on the docks or lawn. All garbage must be disposed of in dumpster.
- 13. The bar shall be closed when a regular or special meeting of the membership is in progress.
- 14. The Board of Directors, or their appointees (i.e. Bar Manager, Dock/Harbor Master), shall be the only members authorized to provide direction to an employee of the club.
- 15. Use of the pool table is restricted to persons 16 years of age and older, unless accompanied by a club member. The pool table shall be returned to usable condition after being moved or used during a club function. It shall be kept covered when not in use.
- 16. No authorized person shall carry and/or use firearms in the clubhouse or on Toledo Sailing Club property.
- 17. No person shall use illegal drugs on club property. Club property includes the clubhouse, parking lot, grounds, decks, patio and docks. No person shall use illegal drugs on any boat moored within the club marina.
- 18. Anyone coming into the club during a club function, and participating in any way in the activities of the function, shall pay any associated fee.
- 19. Children twelve (12) years of age or under must be accompanied by an adult at all times while on the club premises. No twenty-one (21) years of age or under are allowed to sit at the bar, and no children fifteen (15) years of age or under are allowed in the kitchen.
- 20. The party room at the club can be rented by any member thru the Rear Commodore. The bar must always remain open to members. During the time period of May 1st thru October 31st, the party room can be rented on Fridays, Saturdays and Sundays only after receiving Board approval. Terms of room rental are per current Room Rental Agreement form.
- 21. Current bridge officers of an acknowledged AYC club can only remove club burgees from the club. Said officers must sign-out burgee on the sign-out sheet near visitor's book identifying officer, affiliated club, date, and burgee identification number at minimum.
- 22. The Board of Directors will post these house rules in the club and any additional rules from time to time as deemed necessary for the betterment of the club. Any and all rules may be changed or rescinded by the Board of Directors, and if necessary, revise the house rules annually. Rules added shall have the same force and effect as though incorporated herein.
- 23. The last member(s) to leave the Club house shall ensure the doors are locked and the lights and TV are turned off.
